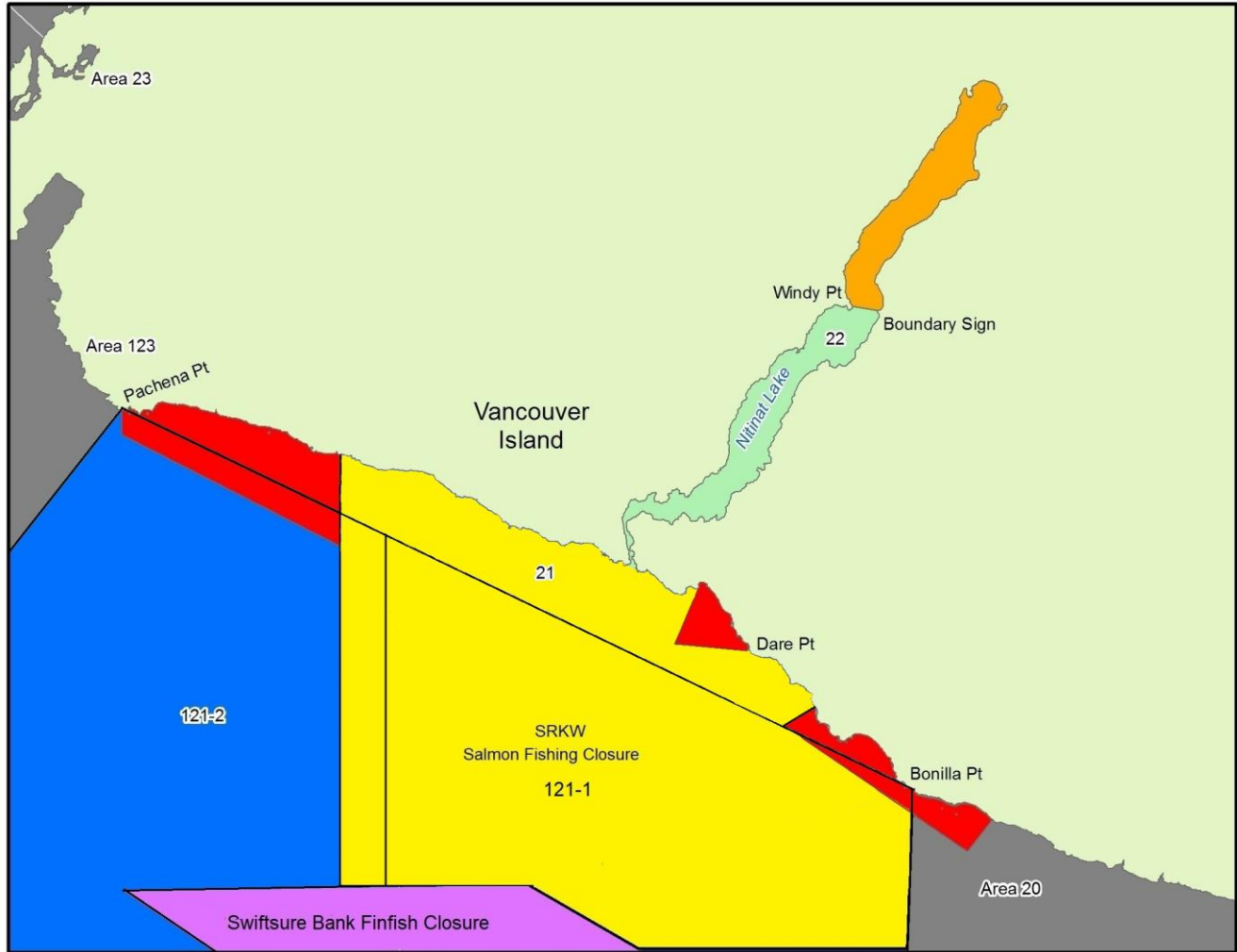

Aug 1 – Dec 31	2 Chinook per day 2 Coho per day, hatchery marked only
Jul 15 – Dec 31	2 Chinook per day 2 Coho per day, hatchery marked or unmarked
Jul 15 – Jul 31	2 Chinook per day 2 Coho per day, hatchery marked or unmarked
Aug 1 – Oct 31	Finfish closure

Jul 15 – Jul 31	2	2 Chinook per day 2 Coho per day, hatchery marked or unmarked	That portion of Area 22 (Nitinat Lake) northeasterly of a line from a boundary sign at Windy Point to a boundary sign on the opposite shore.

All year	0	Finfish closure	<p>Those portions of Subareas 121-1 and 121-2 inside a line from 48°34.00'N and 125°06.00' W, then to 48°34.00' N and 124°54.20' W, then to 48°29.62' N and 124°43.40' W, then following the International Boundary between Canada and the United States to 48°29.55" N and 124°56.20' W, then in a straight line to the point of commencement <b>[Swiftsure Bank]</b>.</p> <p>Under the Canada Shipping Act, there is also a vessel prohibition in those portions of Subareas 121-1 and 121-2 inside a line commencing at a point in water located at 48°34.000'N and 125°06.000'W [Northwest Boundary] due east to a point in water located at 48°34.000'N and 124°54.200'W [Northeast Boundary], thence southeasterly to a point in water at 48°32.100'N and 124°49.518'W [Southeast Boundary], thence due west to point in water located at 48°32.100'N and 125°01.843'W [Southwest Boundary], and thence northwesterly back to the point of commencement. <b>[Swiftsure Bank Interim Sanctuary Zone]</b>.</p>
Jul 16-Oct 31	0	Salmon Fishing Closure	No recreational or commercial fishing for salmon in Area 21, and portions of Subareas 121-1 and 121-2.
