SHELLFISH GROWERS: HELP KEEP MARINE WILDLIFE FREE FROM **ACTIVE OR LOST GEAR**

Active or lost gear can entrap or injure marine wildlife, including whales, sea turtles, and sharks.

Improper activities on a shellfish farm can also damage sensitive and important coastal habitat such as eelgrass beds, rocky reefs, salt marshes, and kelp forests.

How you operate can make a difference in protecting wildlife and their habitat.

REPORTING **MARINE** WILDLIFE **INCIDENTS**

If you see an entangled, injured, stranded, or dead marine mammal or sea turtle, please take the following steps:



Take photos and videos of any entangled gear and the animal.

Photos can provide useful information about the animal and the nature of the incident.



Do not attempt to help or disentangle the animal without first obtaining direction from DFO officials.

You could injure yourself and/or the animal.



Stay with the animal, if safe to do so, until an authorized responder arrives or DFO gives you further direction. Maintain the minimum required approach distance from marine wildlife.1

100 m distance from most whales, dolphins, and porpoises; 200 m if an animal is in resting position or with a calf. At-risk Killer Whales require more distance (200-400 m); distances may vary by area or time of year. THE ROPES, NETTING, AND OTHER MATERIALS IN USE AT SHELLFISH FARMS CAN POSE A THREAT TO MARINE WILDLIFE

Take these measures to help protect marine wildlife and their habitat:

As of September 2020, 12 of the 26 marine species in Canadian Pacific waters listed under the *Species At Risk Act* (SARA) are considered to be Endangered or Threatened.

From marine mammals like Killer Whales to molluscs like Northern Abalone, all Endangered and Threatened species and their habitats are afforded legal protection in Canada to prevent their further decline. It is against the law to kill, harm, harass, capture, or take an individual of a species listed as Extirpated, Endangered, or Threatened under SARA, or to destroy any part of its identified critical habitat.



Design and install all infrastructure to withstand all types of weather conditions.

Regularly inspect your gear to ensure that it is secured, in good condition, and functioning as intended.




Reduce excess and loose lines.





Recover any lost gear to prevent pollution and wildlife entanglements.





Educate yourself and your staff

on the requirements for protecting marine wildlife, particularly species at risk and their habitat.

REPORT ENTANGLED, INJURED, OR DEAD MARINE WILDLIFE





Report sighting of entangled, injured, or dead marine mammal, sea turtle, or shark immediately.



Take photos and videos of the entangled gear and the animal.



Do not attempt to disentangle the animal yourself, unless authorized to do so by DFO.



Stay with the animal, if safe to do so, at the appropriate distance.¹

¹100 m distance from most whales, dolphins, and porpoises; 200 m if they are in resting position or with a calf. Killer Whales in BC require more distance (200-400 m); distances may vary by area or time of year.
